In a letter dated June 27, 2017, Mr. JJ Samuel A. Soriano informed the management of Jackstones, Inc. (the "Company"), that by virtue of a Sale and Purchase Agreement dated 14 June 2017 and the Assignment Agreement dated 20 June 2017 executed by and between MHB-Bank AG and Mr. JJ Samuel A. Soriano, Mr. Soriano has acquired the loan of Pacific Cement Philippines, Inc. ("PCPI") from MHB-Bank AG which has acquired said loan from the original creditor, ING Deutschland GmbH (formerly ING-BHF Bank Aktiengesellchaft).

As per the records provided by Mr. Soriano, the Company was informed that ING Deutschland GmbH, by virtue of a Master Agreement, effectively assigned and transferred several loan obligations, including the PCPI loan, to MHB-Bank AG.

Pursuant to such acquisition of the loan by Mr. Soriano, he has executed an Affidavit of Desistance on 23 June 2017 releasing Jackstones, Inc. (formerly NextStage, Inc.) from any liability arising from the Court of Appeals Case No. CA-GR CV No. 89642 entitled "ING-BHF Bank Aktiengesellchaft vs. Pacific Cement Philippines, Inc. and NextStage, Inc." Mr. Soriano likewise previously executed an Indemnity Agreements dated 29 April 2015 holding the Company free and harmless from any claims arising from Court of Appeals Case No. CA-GR CV No. 89642.
