In compliance with the Securities and Exchange Commission ("SEC") Notice dated 12 March 2020, the Company hereby provides its status and measures prepared and to be undertaken in light of the Novel Coronavirus 2019 ("COVID-19") situation.

At the Board Meeting of Jackstones, Inc. (the "Company") held on 13 March 2020, the Board of Directors discussed the following matters and hereby provides the public with the following updates:

- a. The Company and its subsidiary shall be adopting the flexible work arrangement such as, but not limited to, shortened work schedules and work-from-home arrangements for the administrative staff.
- b. All officers and employees shall exercise all the precautionary and hygienic practices being promoted and suggested by the country's health professionals. Social distancing and avoidance of large crowds are advised to all sales personnel. They are also advised to carry antibacterial sanitizers and supplies of tissue paper in the event that contact or exposure to others would be necessary in carrying out their duties.

The open house activities for the advertisement and marketing of its residential development has been cancelled to comply with the directives issued to contain the COVID-19 situation.

The Company expects that there would be delays in meeting sales quotas due to the restrictions imposed by government.

- c. In terms of construction schedule, contractor has assured the Company that there are no expected delays resulting from the COVID-19 situation. The Contractor will also enforce all the same precautionary and hygienic practices during construction.
