On 11 April 2023, the Board of Directors of Jackstones, Inc. ("Company") convened to discuss the possibility of filing for an extension to file the CY2022 Audited Financial Statement, SEC Form 17-A, and Sustainability Report ("Annual Reports"). Due to the voluminous reports and financial documents subject to the audit and the reassignment of workload in the Company's and the financial team's personnel, the Company, through the Audit Committee, has yet to receive the Annual Reports for review of the Board of Directors. Based on its own internal deadline to finalize and secure the Board's approval, the Company cannot complete its review and analysis of the Annual Reports on or before the deadline to file the same on 17 April 2023.
