At the Meeting of the Board of Directors of Jackstones, Inc. ("Corporation") held on March 23, 2015, the following matters were approved:

- 1. Setting April 7, 2015 as the record date for shareholders entitled to notice to attend and to vote at the Annual Meeting of the Shareholders on April 30, 2015;
- 2. Subject to the approval of the stockholders, amendment of the Articles of Incorporation and By-laws on the following:
 - a. Change the Corporation's principal address to:

593 Antonio Drive, Bagumbayan, Taguig City, Philippines 1630

b. Amendment of Article I, Section 1 of the Corporation's By-laws to read as follows:

Section 1. Annual Meetings – The annual meeting of the stockholders of the Corporation shall be held at the principal office of the Corporation at 593 Antonio Drive, Bagumbayan, Taguig City, Philippines 1630, or at any place designated by the Board of Directors in the city or municipality where the principal office of the corporation is located, on the last day of April in each year, unless such day shall be a legal holiday, in which case it shall be held on the next following business day.

c. Amendment of Article II, Section 9 of the Corporation's By-laws to read as follows:

Section 9. Compensation – Directors of the Corporation shall receive a per diem of TWO THOUSAND PESOS (Php2,000.00) for each meeting of the Board attended by them. Nothing herein contained shall prevent directors from acting in some other capacity or office or from receiving compensation therefor.

The Board of Directors had a discussion on the direction of the Corporation and manifested its desire to further discuss this matter during the Annual Shareholders' Meeting.
